Nominations cannot be withdrawn **after 12:00 noon AEST on 13 April 2018**.

Candidates may submit a statement limited to 250 words in support of their candidature to be included with ballot material. Statements should be submitted to the Returning Officer as a word document either by email to nswelections@aec.gov.au or via post on CD/USB. Only statements which comply with the Association's rules and are received by the Returning Officer prior to **12:00 noon AEST on 13 April 2018** will be published.
