Only statements which comply with the Association's rules and are received by the Returning Officer prior to **12:00 noon AEST on 13 April 2018** will be published. 4. As a candidate you will be sent an acknowledgment.
5. It is your responsibility to ensure that your nomination is received by the Returning Officer BEFORE nominations close.
